Important COVID Vaccine Update from the PA Dept. of Health

Holiday Ordering Cadence

Christmas

- No vaccine deliveries will occur Thursday, December 23 through Monday, December 27.
- If you need vaccine for clinics scheduled on the holiday weekend
 - Submit your orders early, preferably the week of Dec. 13th.
- Orders placed on the week of December 20th may not be delivered until after January 4, 2022.

Normal deliveries will be carried out on Tuesday Dec. 28 and Wednesday Dec. 29.

New Year Holiday

- No vaccine deliveries will occur Thursday, December 30 through Tuesday, Jan 4.
- If you need vaccine for clinics scheduled on the holiday weekend
 - Submit your orders early, preferably the week of Dec. 13th in anticipation of the limited work hours over Christmas week.

Transition to Pfizer Vaccine's Gray Cap Formulation

- Pfizer COVID-19 purple cap vaccine vials for ages 12 years and older will be replaced with the Pfizer COVID-19 gray cap vaccine vials.
- Jurisdictions and providers should maximize use of all remaining Pfizer doses prior to ordering the Tris-Adult formulation.
- Providers should continue to use the purple cap vaccine they have on hand.
- To avoid mistakes during this period of transition when both products may be in circulation, these products should not be offered/administered at the same time.
- Provider sites should ideally carry only one Pfizer adult formulation at a time.
