## COVID-19 Update and Resources 3/20- 4/2



Representative Torren Ecker, of the Pennsylvania General Assembly, is set to offer an amendment to [House Bill 605](#), providing for the expedited and efficient resolution of lawsuits arising out of exposure to COVID-19. The amendment issues limited civil immunity from liability for health care providers for actions during the COVID-19 pandemic.

## PA & Federal Updates

Happy Passover and Easter to all those who celebrate!

- There were 53,104 new cases in Pennsylvania since our last update on 3/19, bringing the total case count to 1,033,406 (includes confirmed and probable cases) in all 67 counties in PA. Statewide percent positivity for the week of March 19 - 25 has increased to 7.6%. View a breakdown of cases by region, county, gender, ethnicity, etc. [here](#).
- Starting April 19th, all Pennsylvanians (16+) will be eligible to schedule a vaccination appointment. This opening in the state's vaccine distribution plan follows the news that residents in Phase 1B can schedule an appt. as of April 5th and Phase 1C as of April 12th. - The PA (DOH) has release updated guidance on summer camps and recommendations for social-distancing in K-12 schools. [Read more here](#). View below the AAP's guidance on the same subjects.
- Recent reports suggest that PA COVID-19 vaccination rates are largely county-dependent, leaving many residents of "rural" counties, which account for 72% of all PA counties, increasingly less protected against the virus than the residents of the state's urban and suburban areas. ### COVID-19 Vaccine Projection

- Tentatively projecting authorization of COVID-19 vaccine for 12 years and up by summer 2021.
- Pfizer/BioNTech likely to be authorized first – 2 doses 3 weeks apart.
- Co-administration with other vaccines unlikely - "black out period" (14 days prior, 3 weeks in between COVID vaccine doses, 14 days after)

- As of March 25, nearly 3.4 million children have tested positive for COVID-19 since the onset of the pandemic, representing 13.4% of all cases in states reporting cases by age. Over 64,000 new child COVID-19 cases were reported last week. Despite a steady decline of cases over the last two months, there was a slight increase in reported case last week.
