COVID-19 Statement & Resources

Dear Members and Partners of the PA Chapter, AAP,

Without question, the health and well-being of every individual in the PA AAP community is our top priority. This commitment applies to the current situation with COVID-19 as well as in our ongoing mission dedicated to the health and well-being of children and the value of pediatric practice.

As we continue to monitor the COVID-19 outbreak in Pennsylvania we are making adjustments to ensure the safety of our members, partners, staff and community at large. We are committed to following all recommendations from the CDC, state and local public health departments and the national AAP and we are modifying gatherings and workflow as necessary.

We have made the following adjustments to events through May 10th:

- The 2020 Pediatric Conference is rescheduled for March 20 and 21, 2021 at the Gettysburg Hotel.
- Other in-person programs, trainings, etc. will be postponed or converted to virtual meetings through May 10th.
- All national AAP events are cancelled through May 10th, including the Legislative Conference.
- The Chapter office will be closed for the next few weeks, with staff working remotely. We ask for your patience in returning calls and emails.

The postponement of future events remain under scrutiny, and all such determinations will be guided by our Executive Committee, based on the most current recommendations of infectious disease specialists, AAP, Pennsylvania Department of Health and the CDC.

AAP Clinical Guidance

The AAP recently published [recommendations](#) to provide pediatricians some best practices for how to care for patients under the current challenging conditions. Some key takeaways include:

- **Continue to offer well-child check-ups.** Consider conducting well visits for newborns, and for infants and younger children who require immunizations, and rescheduling well visits for those in middle childhood and older to a later date.
- **Be flexible.** Consider modifying your clinical schedule and physical space to minimize risk. Increase capacity to deliver telehealth when possible.
