COVID-19 Updates

Pa. has 986 new cases, bringing statewide total to 60,622, in all 67 Pa. counties. [Learn more](#). 4,349 of the total cases are in health care workers and 12,937 are among residents in long-term care facilities, which include nursing homes and personal care homes. Governor Tom Wolf announced 12 additional Pennsylvania counties will move to the yellow phase of reopening at 12:01 a.m. on Friday, May 22.

With these additional 12 counties, there will be a total of 49 counties in the yellow phase. The remaining 18 counties are in the red phase. [Learn more](#)

The Pa. Department of Health distributed the investigational antiviral medication, remdesivir, to treat patients in the hospital with COVID-19. Fifty-one hospitals across Pa. will be receiving the first shipment over the next few days. [Learn more](#)

Pediatric Multi-System Inflammatory Syndrome Potentially Associated with COVID-19
May 11, 2020

This guidance is based on available information about COVID-19 and subject to change as additional information becomes available.

A pediatric multi-system inflammatory syndrome, recently reported by authorities in the United Kingdom, is also being observed among children and young adults in New York City and elsewhere in the United States.

Clinical features vary, depending on the affected organ system, but have been noted to include features of Kawasaki disease or features of shock; however, the full spectrum of disease is not yet known. Persistent fever and elevated inflammatory markers (CRP, troponin, etc.) have been seen among affected patients. Patients with this syndrome who have been admitted to pediatric intensive care units (PICUs) have required cardiac and/or respiratory support. Only severe cases may have been recognized at this time.

- Cases compatible with multi-system inflammatory syndrome have been identified in children in New York City and United Kingdom hospitals.
- These cases are characterized by persistent fever and features of Kawasaki disease or toxic shock syndrome. Abdominal symptoms in these patients are common.
- These cases may require intensive care unit admission for cardiac or respiratory support.
- Polymerase chain reaction testing for SARS-CoV-2 may be positive or negative.
- Early recognition and specialist referral are essential, including to critical care if warranted.
- Any patient meeting these criteria should be immediately be reported to the PA DOH through PA-NEDSS or by calling 1-877-PA-HEALTH (1-877-724-3258).

PA DOH Promotes Well Child and Immunization Visits with Pediatricians

During the Thursday, May 14th Department of Health COVID-19 update, Secretary Levine shared about the importance of well child visits, keeping up with vaccinations, and the precautions being taken by PA's pediatricians. PA AAP has been working hard to collaborate with the PA DOH on this important message to families.

During the Q and A with the media, Dr. Levine said (found at the 28:11 mark): "I'm hearing from Pediatricians – there was a report in the Journal of Pediatrics – about missed opportunities for vaccines because of the COVID-19 pandemic. I don't have specific information about that in Pennsylvania, but we know that during the stay at home period , people have not been going for their well child visits and that's

why we made our specific comments today. **We've had ongoing discussions with the PA Chapter of the American Academy of Pediatrics. There was a conversation between our staff and the AAP this week. We're strong partners and we collaborate with them all the time.** We just want to make sure that children get all the immunizations they need to stay healthy."

As we roll out of #PedsPutKids1st Well Child Campaign, we are very happy to receive state acknowledgement on this extremely important initiative aimed to protect the health and well-being of children.
