COVID-19 Update and Resources 9/19 - 10/2

PA & Federal Updates

PA saw 12,601 new cases since September 18th, bringing the total case count to 161,284 (includes confirmed and probable cases) in all 67 PA counties. View a breakdown of cases by region, county, gender, ethnicity, etc. <a href="https://example.com/here.co

Pa. released its weekly COVID-19 Early Warning Monitoring System Dashboard update. Find information such as community transmission data and changes to the state's travel recommendations here.

Pa. DOH launches COVID Alert PA, the official mobile app by the Pennsylvania Department of Health (DOH) that uses the Exposure Notification System (ENS) provided by Apple and Google. Learn more and download here

Pa. Secretary of Health Rachel Levine, MD, held a press conference to provide COVID-19 updates. She stressed the need to continue mitigation measures and emphasized that many individuals diagnosed with COVID-19 experience long term symptoms. This <u>CDC study released</u> in July showed that, in a multistate telephone survey of symptomatic adults, 35% had not returned to their usual state of health when interviewed 2-3 weeks after testing.

A new CPT code has been created for additional expenses (such as PPE) related to the public health emergency. CMS has not yet confirmed whether it will cover the use of the code. <u>Learn more</u>

CMS released data on service use among Medicaid and CHIP beneficiaries age 18 and under during COVID-19. Data shows that rates for vaccinations, primary, and preventive services among children in Medicaid and CHIP have declined significantly compared to the same time period last year. <u>Learn more</u>

The Wolf Administration released a new COVID-19 testing prioritization plan. Testing will be prioritized based on four tiers. <u>Learn more</u>

The U.S. House passed a short-term government funding bill that includes a provision extending the deadline for providers to repay Medicare advance payment loans until after the public health emergency expires. The bill is now being considered by the Senate. Learn more

Considerations for Evaluating Patients for SARS-CoV-2 October 1, 2020

Patients infected with SARS-CoV-2 may present with a variety of symptoms.

- In order to protect public health, it is important to consider COVID-19 in patients presenting with mild symptoms.
- This consideration is especially important in children and young adults.
- If a patient has been exposed to a case of COVID-19, it is recommended that they be tested 2-3 days after exposure, regardless of the presence of symptoms.

Testing and Management Guidance for Patients After Exposure to SARS-CoV-2

September 21, 2020

- Individuals who have been in close contact with a confirmed COVID-19 case should be tested for SARS-CoV-2, regardless of the presence of symptoms.
- SARS-CoV-2 testing may also be advised for individuals who were in a substantial transmission zone and attended a gathering of more than 10 people without universal mask wearing and physical distancing.
- Persons who test positive for SARS-CoV-2 do not need to repeat a test for at least 3 months.

The American Academy of Pediatrics and Children's Hospital Association Weekly Report- state-by-state data on COVID-19 cases in children. On September 24, the age distribution of reported COVID-19 cases was provided on the health department websites of 49 states, New York City, the District of Columbia, Puerto Rico, and Guam. While children represented only 10.5% of all cases in states reporting cases by age, over 624,000 children have tested positive for COVID-19 since the onset of the pandemic. Learn more

Resources for Developing Mass Vaccination Clinics

Mass vaccination clinics involve the administration of vaccine(s) to a large number of people over a relatively short period of time, allowing providers to rapidly and efficiently immunize communities. Due to the unique nature of mass vaccination clinics, they frequently are held in non-traditional or temporary settings, such as in parking lots or large indoor spaces. Patient flow may be managed through a variety of venues, such as walk-through, drive-through, and curbside clinics, or by using mobile medical units.
