COVID-19 Update and Resources 11/13- 11/19

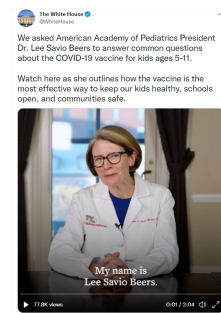
As we head into the holiday season with [flu vaccinations down from this time last year](#), the Chapter is dedicated to providing you timely updates on flu and COVID-19 transmission and vaccination data on our social media channels.



PA & Federal Updates

- There were 47,854 new cases in Pennsylvania since our last update on 11/12 bringing the total case count to 1,666,724 (includes confirmed and probable cases) in all 67 counties in PA. Statewide percent positivity for the week of Nov. 5 - 11 stood at 10.3%--an increase from 9.3%, recorded Oct. 29 - Nov. 4. - Regarding the ongoing debate and legal proceedings surrounding Acting Secretary of Health Alison Beam's school mask mandate, the Chapter continues to advocate that the mandate not be lifted--neither on the Governor's prescribed date of 1/17/22 nor that of the court (12/4/21). Universal masking in schools remains the position of both the PA AAP and AAP.
 - With the help of the National AAP and Democracy First, the PA AAP signed onto an amicus brief in the case of Jacob Doyle Corman, III, et al., vs Acting Secretary of the Pennsylvania Department of Health. Unfortunately, the intermediate court assigned to this case lifted the stay of the mandate, meaning that the statewide mandate will end on 12/4/21 unless the PA Supreme Court takes action. - The PA Department of Health reported the following around COVID-19 vaccinations. The data were pulled from cases between January 1, 2021 and November 2, 2021. Learn more [here](#).
 - 88% of reported COVID-19 cases were in unvaccinated or not fully vaccinated people.
 - 90% of reported hospitalizations with COVID-19 as the primary diagnosis/cause of admission were in unvaccinated or not fully vaccinated people.
 - 89% of COVID-19-related deaths were in unvaccinated or not fully vaccinated people.

- As of November 11, more than 6.6 million children have tested positive for COVID-19 since the onset of the pandemic, representing 16.8% of all cases in states reporting cases by age.
