#### **Pa. Department of Health has reported 7,016 COVID-19 cases in Pennsylvania.**

As of April 2, 2020 -- Pa. has 1,211 new cases, bringing statewide total to 7,016 in 62 counties. 345 of the cases are health care workers. [Learn more](#)

[All 67 Pennsylvania counties are now under a Stay at Home order](#) through April 30. All individuals in counties subject to this policy must STAY AT HOME except for certain essential activities and work to provide life-sustaining business and government services.

#### **Independent Practices – SBA programs open Friday, April 3.**

Starting today, April 3, small businesses and sole proprietorships can apply for loans through existing SBA lenders. Starting April 10, independent contractors and self-employed individuals can apply for loans through existing SBA lenders. Other regulated lenders will be available to make these loans as soon as they are approved and enrolled in the program.
