COVID-19 Updates

Pa. has 866 new cases, bringing statewide total to 66,258, in all 67 Pa. counties. [Learn more](#). View a breakdown of cases [here](#). Approximately 4,871 of the total cases are in health care workers. In nursing and personal care homes, there are 14,113 resident cases of COVID-19, and 2,306 cases among employees, for a total of 16,419 at 570 distinct facilities in 44 counties.

There are several online tools that offer national and state coronavirus data as states begin the reopening process. Check out this ProPublica site that measures the trajectory of each state's positive tests as a percentage of overall tests [here](#). The U.S. Department of Human Services has provided \$225 million to Rural Health Clinics (RHC) for COVID-19 testing. Almost \$3.5 million of that funding has been allocated to 70 Pennsylvania RHCs. [Learn More](#)

Pennsylvania counties in the red phase are under a [Stay at Home Order](#) through June 4. Counties in the red phase are expected to move to yellow by June 5 at 12:01 a.m.

The following counties will move to the yellow phase on May 29: Dauphin, Franklin, Huntingdon, Lebanon, Luzerne, Monroe, Pike, and Schuylkill. 17 counties will move to green on May 29: Bradford, Cameron, Clarion, Clearfield, Crawford, Elk, Forest, Jefferson, Lawrence, McKean, Montour, Potter, Snyder, Sullivan, Tioga, Venango and Warren.
