### **COVID-19 PA Updates**

PA saw 3,449 new cases since last Friday, bringing the total case count to 80,762 (includes confirmed and probable cases) in all 67 PA counties. View a breakdown of cases by region, county, gender, ethnicity, etc. [here](#).

#### **News**

- More than half of the state is now in the green phase of the process to reopen, with Dauphin, Franklin, Huntingdon, Luzerne, Monroe, Perry, Pike and Schuylkill counties going green today.
- At 12:01 a.m. on Friday, June 26, Berks, Bucks, Chester, Delaware, Erie, Lackawanna, Lancaster, Lehigh, Montgomery, Northampton, Philadelphia and Susquehanna Counties will move to green. Note: Philadelphia County met the criteria and will move to the state's green phase on June 26; however, local officials will maintain some additional restrictions until July 3. [Read more](#).
- Pennsylvania is one of just three states that has had a [downward trajectory of COVID-19 cases](#) for more than 42 days.
- Pennsylvanians are urged to take proper precautions to prevent against tick bites and recognize the symptoms of Lyme disease, as some symptoms of Lyme disease are similar to those of COVID-19. [Read more](#).
- [Providers of services supporting Pennsylvanians with intellectual disabilities and autism](#) will receive \$260 million in CARES Act funding.

### **Provider Relief Fund Portal OPEN - July 20th is Deadline to Apply**

#### **Provider Relief Fund:**

- On June 10th, the Department of Health and Human Services (HHS) **launched an [online portal](#)** for pediatricians, pediatric medical subspecialists and pediatric surgeons to apply for financial relief from the CARES Act Provider Relief Fund.
- \$15 billion is available for Medicaid and CHIP providers.
- Not first come, first serve! (**All eligible applicants will receive funds.**) **Deadline to apply is July 20th.**
- Any practice or clinician who has billed Medicaid and CHIP, including Medicaid/CHIP managed care plans, from January 2018-December 31, 2019, provided patient care after January 31, 2020, and who has not received any funding from the Provider Relief Fund general distribution, can apply. HHS has

listed eligibility criteria [here](#).

- Expected payments equivalent to at least 2% of annual revenue for patient care (not limited to Medicaid and CHIP)
